

CITY VENDORS / POTENTIAL VENDORS CONFLICT OF INTEREST QUESTIONNAIRE (FORM CIO)

On May 23, 2005, the Texas Senate passed House Bill No. 914 adding chapter 176 to the Local Government Code which imposed new disclosure and reporting obligations on Vendors and Potential Vendors to Local Government Entities beginning in January 2006.

Chapter 176 of the Local Government Code, adopted in 2005 through House Bill 914, requires a person who contracts or seeks to contract with for the sale or purchase of property, goods, or services to file a statement disclosing the person's affiliations and business relationships with each member of the governing body and executive officer of the entity, to be filed.

On May 25, 2007, the rules were relaxed to provided that a vendor questionnaire **need not be filed unless** the person has a business relationship with the City and has (a) an employment or other business relationship with an **officer of the City** or a family member of the officer; or (b) has given an officer of the City, or a family member of the officer, one or more gifts with an aggregate value of \$250.

The vendor is no longer required to update this form annually. Now, the vendor only need file an updated questionnaire not later than the 7th business day after the date the originally filed questionnaire becomes inaccurate or incomplete.
