CM Claridge moved, seconded by CM Rodriguez to approve Ordinance #1427-2024 and #1428-2024. All voted "Aye".

# ORDINANCES/RESOLUTIONS REQUIRING COUNCIL APPROVAL/ACTION:

11. CONSIDER APPROVAL OF ORDINANCE #1429-2024 AMENDING ARTICLE 12.05 "STOPPING, STANDING & PARKING" OF THE RIVER OAKS CODE OF ORDINANCES (2020) SPECIFICALLY IN SECTION 12.05.012 "SPECIAL STOP INTERSECTION" SUBSECTION (a) "MILLER DRIVE" CREATING A 3-WAY STOP INTERSECTION AT MILLER DRIVE AND YALE STREET.

There have been a few complaints about having limited visibility at the intersection of Yale and Miller. Recommendation is to add two stop signs. Council would like to look into adding a stop sign at Pomona.

# CM Forester moved, seconded by CM Claridge to approve Ordinance #1429-2024. All voted "Aye".

12. CONSIDER APPROVAL OF ORDINANCE # 1430-2024 AMENDING CHAPTER 4 "BUSINESS REGULATIONS" OF THE RIVER OAKS CODE OF ORDINANCES (2020) SPECIFICALLY IN ARTICLE 4.10 "SHORT-TERM RENTAL" REVISING SECTION 4.10.002 "DEFINITIONS" AND REVISING SECTION 4.10.004 "REGULATIONS" SUBSECTIONS (m) "HOTEL OCCUPANCY TAXES" AND (n) "REQUEST FOR OCCUPANCY HISTORY.

In the ordinance, it did not state the actual percentage of hotel/motel tax to collect. We will include language to the maximum rate allowed by law. Next need to add language that the report and payment are due 45 days after the quarter ends and to add a 10% penalty after 45 days if the report and payment are not received.

# CM Holland moved, seconded by CM Forester to approve Ordinance #1430-2024. All voted "Aye".

13. CONSIDER APPROVAL OF RESOLUTION NO. 1126-2024 CHANGING THE DATE ON WHICH THE CITY HOLDS ITS GENERAL ELECTION FOR OFFICERS TO THE NOVEMBER UNIFORM ELECTION DATE PURSUANT TO SECTION 41.0052 OF THE TEXAS ELECTION CODE, PROVIDING AN EFFECTIVE DATE.

Moving the election would save the city about \$8,000-\$10,000 for a regular election. Council would like more research done to see what the cost savings would be in a non-presidential election.

CM Claridge moved, seconded by CM Forester to approve Resolution #1126-2024. CM Claridge, CM Forester and CM Rodriguez voted "Aye". CM Holland voted "Nay". Motion passed.

14. CONSIDER APPROVAL OF RECOMMENDATION FROM THE PARKS BOARD TO APPOINT RYAN JILL FOX AS A MEMBER DIRECTOR ON THE BOARD OF DIRECTORS OF THE PARKS FOUNDATION OF RIVER OAKS (501C3, NON-PROFIT ORGANIZATION) AND TO APPOINT A CITY COUNCIL MEMBER LIAISON PURSUANT TO 2.16 "NON-VOTING CITY COUNCIL LIAISON" OF THE BYLAWS OF THE PARKS FOUNDATION OF RIVER OAKS TO ACT AS A LIAISON BETWEEN THE BOARD AND THE CITY COUNCIL.

Mayor Houk introduced Jill Fox. She designed the 75<sup>th</sup> logo and is serving on the Park Board. Jill will replace Jeremy Bell and Leigh Ann Turner will be the council liaison.

CM Forester moved, seconded by CM Claridge to approve adding Jill Fox as a member and Leigh Ann Turner as the council liaison. All voted "Aye".

15. CONSIDER APPROVAL TO EXPEND FUNDS FROM THE 2021 CERTIFICATE OF OBLIGATION BONDS IN ORDER TO REPLACE AIR CONDITIONING UNIT AS A JUSTIFIABLE EXPENSE FOR CITY COMPLEX IMPROVEMENTS ON THE ANNEX BUILDING THAT SERVICES THE PUBLIC WORKS ADMINISTRATION OFFICES.

The unit failed at the public works administration building. The low bid was \$13,285.00.

CM Holland moved, seconded by CM Claridge to approve purchasing the air conditioning unit out of the CO bond. All voted "Aye".

16. CONSIDER APPROVAL TO ORDER DUAL PLAQUES FOR THE TIME CAPSULE MONUMENT IN FRONT OF CITY HALL FOR BOTH THE  $50^{\text{TH}}$  AND  $75^{\text{TH}}$  YEAR ANNIVERSARY.

The estimated cost would be \$4,000.00 but maybe closer to \$3,000.00. The council would like to remove the Public Works Superintendent and add the City Secretary.

CM Forester moved, seconded by CM Claridge to approve the plaques with removing the Public Works Superintendent and adding the City Secretary. All voted "Aye".
