# **WORKSHOP/ACTION FROM WORKSHOP:**

6. WORKSHOP: DISCUSSION OF FISCAL YEAR 2025 CITY OPERATIONAL BUDGET PROPOSAL AS SUBMITTED BY THE CITY MANAGER.

Enclosed is the proposed budget, tax rate study, Police step plan, Fire new step plan, and the five-year budget plan. This proposed budget is based on the proposed tax rate. The Fire step plan is a 8.63% increase, the Police step plan is a 3.4% increase, and all other employees is a 3% increase. The differences in General Fund are: New Fire step plan \$72,289.00 increase, Police step plan \$52,603.20 increase, other employees \$29,087.00 increase, medical insurance (18.36%) \$41,770.00 increase, TML insurance \$1,995.66 increase, from the 5-year plan \$119,469.00 shortfall, ambulance service (July-Sept) \$20,000.00 new expense, Incode 10 upgrade \$30,500.00 new expense, and building repairs (HVAC system) \$8,000.00 new expense. Revenue from the CISD school bond building permits is \$447,500.00. This budget proposal does not include a residential garbage rate increase but does include a commercial garbage rate increase. Marvin & Paula's salary is reimbursed by EDC, TIRZ, and Water. Next year (2025-2026) enterprise vehicles will be sold so we probably will get about \$200,000.00 in revenue. The ambulance service is \$80,000.00 per year but we will only owe one quarter, which is \$20,000.00. In Water, there is a sewer rate increase of 2.7%.

General Fund appx \$72,000.00 in the black; Water Sewer appx \$4,000.00 in the black; Crime Control appx \$33.00 in the black; Economic Development appx \$70,000.00 in the black; and Storm Water appx \$40,000.00 in the red.

The Hotel/Motel tax that we collect from short term rentals, we cannot use in the General Fund for operating expenses. We can only use this for tourism (fireworks, parade, springfest, etc).
