7. DISCUSSION AND/OR ACTION ON TERMINATING BUS SERVICE WITH FORT WORTH TRANSPORTATION AUTHORITY ON MARCH 27, 2024 AND ENTERING INTO AN AGREEMENT WITH FORT WORTH TRANSPORTATION AUTHORITY FOR MOBILITY-IMPAIRED TRANSPORTATION SERVICE.

Detra Whitmore was present. This contract is for the Access Paratransit Service. The fee for the Access Paratransit is \$40.33 per trip and will increase 5% in each extended term. Since the city terminated the bus service, it is up to the city to notify the residents of this termination. The bus shelter and the bus stops will be removed after the termination date.

Member Holland moved, seconded by Member Chisholm to recommend to the City Council to approve entering into an agreement with the Fort Worth Transportation Authority for Mobility-Impaired Transportation Services only. All voted "Aye".

8. GROUP REPRESENTATION OF BUSINESSES IN THE 5400 BLOCK OF RIVER OAKS BLVD (5400-5412) REQUESTING EDC FUNDING PARTICIPATION FOR AN UPCOMING GROUP EVENT.

Austin Burkholder with Atomic Then & Now at 5410 River Oaks Blvd was present. Six businesses are included in this request (5400-5412 River Oaks Blvd). This is for an open house for this block of businesses. Requesting any type of financial assistance for this community event. Looking at April 6th (evening) and April 7th (morning) for this event.

President Houk moved, seconded by Member Holland to approve up to \$500.00 at the City Managers discretion. All voted "Aye".

Member Holland moved, seconded by VP Richardson that the River Oaks Economic Development Corporation finds that pursuant to the Local Government Code Title 12 "Planning and Development", Chapter 505 "Type B Corporations" to recommend to the City Council to approve the request from Faded Art Barbershop at 5408 River Oaks Blvd to enter into a Development Agreement for a Business Improvement Grant in the amount of \$2,000.00 (50% matching grant for strip center) for exterior improvements pending proof that all taxes are current on the property, the applicant provides a signed repayment clause and in conclusion I find that the applicant is qualified for expenditure under Resolution #907-2018 pursuant to Section 505.158 of the Texas Local Government Code that the project is authorized for the expenditures of 4B funds having been found suitable to promote or develop new or expanded business enterprises within the City that create or retain jobs. All voted "Aye".

Chief Shelley did not recommend having the fireworks at the center because it is too close to residential property, the field will be dry, attendance will increase which could cause problems if something does happen, access for emergency vehicles will be diminished, and parking areas to the proposed launch area is dangerously too close. Years ago, fireworks were at the center.

Mayor Houk moved, seconded by Member Chisholm to spend up to \$9,600.00 and let City Manager Gregory make the decision. All voted "Aye".
